

"It is always about color" - Patrick Gabaldon



The U.S./Mexico border, particularly the El Paso, Texas/Ciudad Juarez, Chihuahua region is composed of many businesses (small and large) that benefit from the movement from people across borders.

Businesses in the U.S., especially today in the changing employment atmosphere, are seeking to hire specialized and trained (professional) foreign nationals in different specialty areas such as engineering and accounting and for different managerial and executive positions. In addition, some foreign nationals with plans to invest and open new business are bringing their business operations and ideas into the U.S.

With these types of international movements of people taking place more and more frequently, it is important to have a basic understanding of how to begin navigate through the complex system of immigration rules and regulations to successfully acquire work visas for foreign nationals planning to work in the U.S. With this in mind, we will delve into some of the different types of visas most commonly sought out in border region, a basic overview of the processes for acquiring such visas and the benefits of hiring foreign workers for U.S. businesses across the border.

This session will discuss the nuts and bolts of legal writing, include the origins of "legalese," the advantages and disadvantages of taking a plain language approach to legal writing, how the canons of interpretation affect transactional document drafting, and how to strike a balance among precision, brevity, and tradition when writing. The session will also provide practical tips on how to structure legal documents, how to avoid common writing pitfalls, and what persuasive techniques work best when drafting advocacy documents. This session will also discuss ethical duties a writer has in drafting documents, including duties of disclosure and duties of candor to courts.

Session Six: Bankruptcy for Non-Bankruptcy Lawyers 1 hr

No matter the area of practice, lawyers of all kinds are likely to encounter individuals and business in financial distress – whether as a debtor or creditor. When dealing with such situations, attorneys unfamiliar with bankruptcy often fail to identify key issues or overlook available remedies. This presentation will decode the mystery of bankruptcy by introducing non-bankruptcy attorneys to the basic features of individual and business bankruptcies. Topics include basic issue spotting; the effect of a bankruptcy filing; the impact on pending matters; and a basic overview of case progression and outcomes. Even attendees with limited bankruptcy experience will leave the program empowered to address these issues and answer related client questions.

RICHARD L. CLIFTON, JR. is an associate at Schmoyer Reinhard LLP. Prior to joining the firm, Mr. Clifton served as a law clerk to the Honorable D. Gordon Bryant of the Northern District of Texas, and the Honorable Henry J. Bemporad of the Western District of Texas, and as a staff attorney to Justice Yvonne Rodriguez on the El Paso Court of Appeals. His practice encompasses handling all aspects of employment law in state and federal cases. Ricky received his BA from Southern Methodist University, and J.D. from the University of Mississippi School of Law. He is also the Secretary-Elect of the San Antonio Young Lawyers Association.



ABRE' CONNER leads the Law Foundation of Silicon Valley's litigation, direct legal services, and advocacy regarding health equity and the social determinants of health that impact historically excluded communities across Silicon Valley. Additionally, Abre' sits on the Law Foundation's race, equity, and inclusion steering committee and leads work regarding jail conditions in Santa Clara County. At the Law Foundation, Abre' specifically focuses her team's work in community and movement lawyering that centers Black, Indigenous, AAPI, and Latinx communities. Prior to this position, Abre' was a staff attorney with the ACLU Foundation of Northern California, where she advocated for the civil rights and liberties of people in the Central Valley and Northern California. She regularly represented activists, students and parents, and organizers in a myriad of issues including free speech and education rights issues. Previously, Abre' worked at the Center on Race, Poverty, and the Environment, the NAACP Legal Defense and Educational Fund, U.S. Department of Education Office of Civil Rights, and on Capitol Hill.

She is currently the chief policy officer and Speaker of the American Bar Association YLD and a member of the ABA Litigation Section's Children's Rights Litigation Committee. 
