BOARD *of* DIRECTORS

The TYLA Board of Directors is made up of an Executive Committee, Directors, Representatives, and Liaisons.

The Executive Committee consists of the President, President-Elect, Chair, Chair-Elect, Vice President, Secretary, Treasurer, and Immediate Past President. The President-Elect is elected by TYLA membership and the other officers are elected by the Board of Directors, and each elected officer serves a one-year term. Each member of the Executive Committee acts as an advisor to at least one TYLA committee.

The 34 Directors represent 21 districts from around the state and serve as liaisons to the local affiliates in their respective districts. Directors are nominated and elected by the TYLA members in their respective districts, and each elected Director serves a two-year term. Certain Directors serve as chairs or co-chairs of the various TYLA committees, and all Directors serve on at least one TYLA committee.

Representatives include two American Bar Association Young Lawyer Division representatives and a member of the Access to Justice Commission.

Liaisons include a Texas Supreme Court justice, a law school dean, and a law school student.





How Texas Courts Work

Available at <http://howtexascourtswork.tyla.org/>, "How Texas Courts Work," a project graciously sponsored by the Texas Bar Foundation, helps educate Texans about the role, functions, and independence of the Texas judiciary. Consisting of a multimedia website that provides an overview of Texas courts, a video series about what litigants should expect in some of the most common types of cases filed in Texas courts, a video to be played for prospective jurors about jury service prior to voir dire, how to hire an attorney for in-court representation and factors to consider in the process, a guide that contains tips for members of the media who report on trial proceedings and judicial decisions, and a media literacy program for students that simulates the role of a jury in critically analyzing sources of information to resolve disputed issues of fact.




Online Attorney Marketing Guide

Young Gunners Podcast: War Stories Miniseries

The “War Stories” miniseries of the Young Gunners podcast, which is inspired by a San Antonio Young Lawyers Association project of the same name, consists of interviews and conversations with attorneys sharing intriguing and insightful stories about the practice of law targeted toward young lawyers. Update on Animal Abuse Laws

This short update informs the public about updates to federal and Texas state animal abuse laws, including unlawful restraints on dogs, and provides procedures for reporting animal abuse and animals in distress. Printed handouts were distributed to attendees at the Bar Leaders Conference and other events throughout the year, and the electronic resource is available on the TYLA website.

Law-Adjacent Career Guide

This written guide provides information for the public about career paths in the field of law other than becoming a lawyer, including a summary of the regulatory steps to become a certified court reporter/stenographer or court interpreter who assists witnesses and parties with understanding proceedings in Texas courts. TYLA again partnered with the Dallas Association of Young Lawyers to host a law student for the Law Student Summer Program. Kenya Smith served as a legal intern and worked with TYLA's committees to complete legal research projects (in particular, for the How Texas Courts Work project).



Grants

TYLA supports its affiliated young lawyer associations by providing funding to support local programs and projects. The Member Services Committee awarded grants to eight local affiliates totaling \$10,000. The grants provide much needed assistance for service projects that benefit the community, as well as the members of the bar. In awarding these grants, TYLA seeks to provide seed money to get a new project off the ground or expand the scope of an existing project.).

National Trial Competition

TYLA, in partnership with the American College of Trial Lawyers, hosted the National Trial Competition (“NTC”) in San Antonio, Texas, in March 2023.

Hailed as one of the oldest and most prestigious competitions in the United States, the NTC consists of 30 of the best law school mock trial teams from around the nation. Established in 1975, NTC’s purpose is to advance future lawyers’ advocacy through competition amongst peers and interaction with the bench and bar.

Law School Orientations

Throughout the year TYLA representatives and TYLA law student liaisons attended orientations for all of the Texas law schools. Paper Chase Legal Writing Competition

In October, TYLA, in partnership with Baylor Law School, hosted the seventh annual “Paper Chase” writing competition for law students at Texas law schools. TYLA members coordinated with the Law School Liaison and Law Student Liaison to help promote participation in the competition and served as the sole judges of the anonymized entries.

The competition was designed to feature a real-world problem of the type a new associate may face during their first or second year as an attorney. 


Wellness Summit

TYLA and the Houston Young Lawyers Association co-hosted the second annual Wellness Summit on January 12-13, 2023. Featuring speakers such as Erica Grigg (Director of the Texas Lawyers' Assistance Program) and Pamela Benson Owens, the Summit highlighted the serious ramifications of mental health issues in the legal profession and provided solutions and wellness activities such as grounding techniques, yoga, and other wellness tools.

Panel speakers shared their experiences with mental health challenges. Attendees were invited to record their stories to inspire others who might be struggling with mental health issues. Numerous activities were available to learn or experience wellness techniques. Most of all, lots of personal connections were made.

Bar Leaders Conference

The Bar Leaders Conference brings State Bar of Texas and TYLA elected leaders together with lawyers in various leadership positions with local bar organizations and young lawyer affiliates from across the state. This two-day training program inspires and engages effective leaders, addresses common concerns among bar associations, and offers valuable resources available from the State Bar of Texas.

The 2022 conference was held July 22-23 in Houston and was attended by young lawyers from local affiliates across Texas. Attendees enjoyed sessions outlining strategies for effective use of social media, driving up local affiliate membership numbers, successful project rollouts, and creative sources of revenue. A highlight of the conference was the local affiliate showcase, which was an opportunity for local affiliates to showcase their exceptional projects completed throughout the bar year and provide information, materials, tools, and insight for implementing similar successful projects.

Outstanding Young Lawyer of Texas Award Recipient Dominique McLeggan-Brown, Austin

Each year, the Texas Young Lawyers Association presents the Outstanding Young Lawyer of Texas Award to one attorney who has exemplified professional proficiency, service to the profession, and service to the community.

Liberty Bell Award Recipient Yvette Leno, Houston

The Texas Young Lawyers Association presents this annual award to one outstanding non-lawyer who has made the most selfless contribution to his or her community to strengthen the effectiveness of the American system of justice. The Liberty Bell Award recognizes categories of community service that: (1) promote a better understanding of our government, especially the Bill of Rights; (2) encourage a greater respect for the law and the courts; (3) stimulate a deeper sense of individual responsibility of citizens' rights and duties; (4) contribute to the effective functioning of our institutions of government; and (5) instill a better understanding and appreciation of the law.
