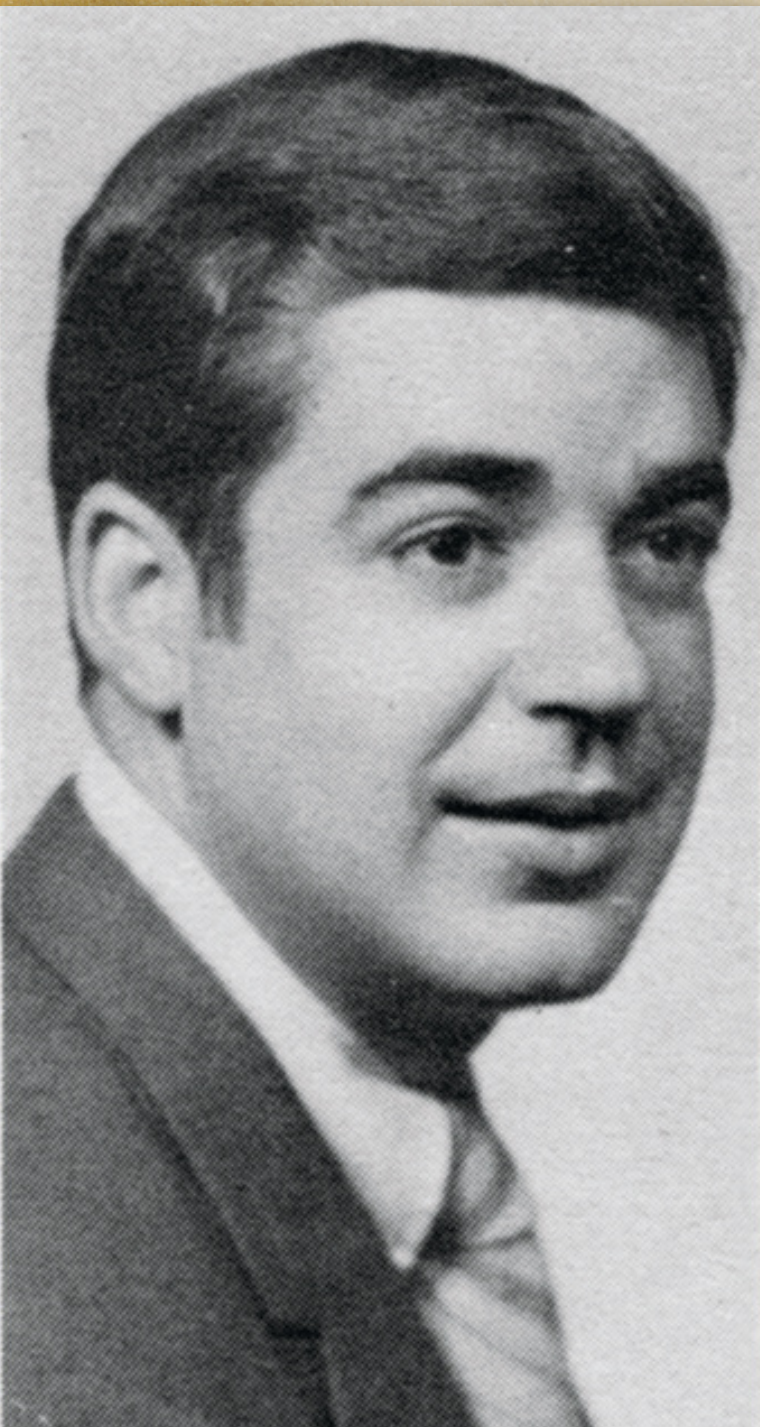


MEMBERSHIP INVITATION

The Inn is named in honor of Joseph M. Pritchard, who died of cancer on May 31, 1979, at the age of 35. He served on the Texas Young Lawyers Association Board of Directors from 1973 through 1977, and was Secretary of the organization from 1976 to 1977.

After graduating from Conroe High School and Stephen F. Austin College in Nacogdoches, he earned a law degree from the University of Houston School of Law in 1968 and was admitted to the Texas Bar the same year.

Mr. Pritchard practiced law with the Houston Legal Foundation from 1968 to 1970. He then joined the firm of Sanders, Sanders, Brian, Finney & Thomas in Amarillo.

An active and civic leader, Mr. Pritchard was chair of the Children's Rehabilitation Center and served on the Board of Stewards at Polk Street United Methodist Church in Amarillo.

He was Treasurer of Theta Chi at Stephen F. Austin College from 1961 to 1964 and was Phi Alpha Delta Law Fraternity justice at the University of Houston from 1967 to 1968.

Joseph M. Pritchard was survived by his wife, Marianne Gerding; his son, Joseph Evan; his daughter, Darcy Jean; his mother, Mrs. Gene M. Pritchard; his sister, Mrs. Mary Lou Pritchard; and his brother, G.R. Pritchard.
